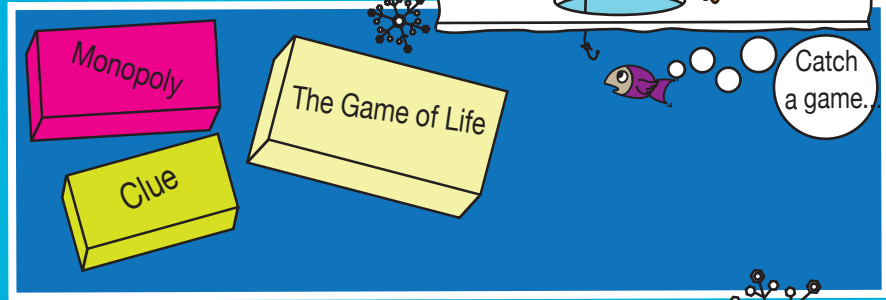
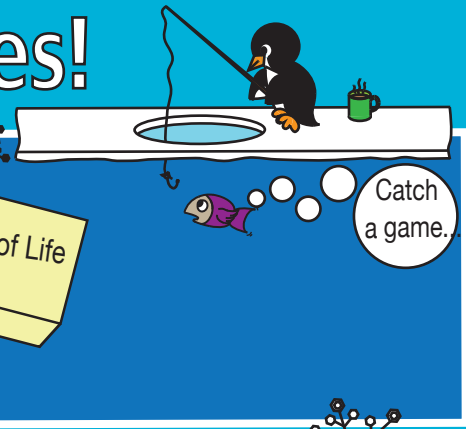


Board Game Giveaway Rules!



Eligibility:

1. The **Board Game Giveaway** is open to legal residents of the fifty (50) states of the United States of America and the District of Columbia (Void where prohibited by law.)
2. Entrants under eighteen (18) years of age must have written permission of a parent or legal guardian.
3. No employee, affiliate, or associate of the Anнимills LLC is eligible to enter or win.
4. Anнимills LLC has the right to verify the eligibility of any prospective winner.
5. Each individual may enter only once a week during the Giveaway period.

How to Enter:

1. No purchase is necessary to enter or win prizes.
2. To enter the **Board Game Giveaway**, fill out an original entry form, found on any "Newspaper Fun" feature, or visit www.readingclubfun.com to print out an entry form. The form must be completed fully, and mailed to **Reading Club Fun, P.O. Box 646, Canton CT 06019**. It must be received by 11:59 PM on Thursday, February 19, 2009, to be eligible for the drawing on Friday, February 20, 2009.
3. All areas on form must be filled out for the entry to be valid, must give us an address to which the Post Office can deliver a package and *must be signed by a legal parent or guardian* (or the entry may be disqualified).

Winner Selection/Prizes:

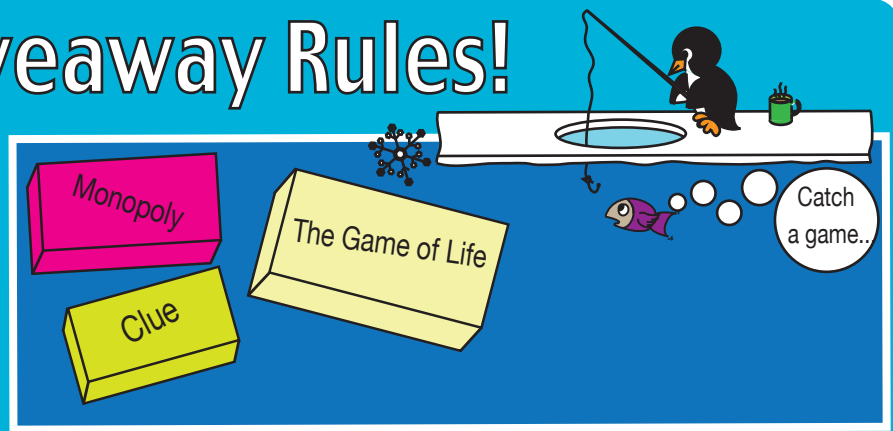
1. Winners will be selected at random by an associate of Anнимills LLC at the end of the contest period.
